Mass Pike (rt90) to Exit 3 (Westfield).
Right off exit go 1.5 miles to Rt.20 west (CVS at corner)
Take a right onto Rt.20 west. Follow Rt.20 (5 miles) to Rt.23
Take a left onto Rt.23 Drive 7 miles to Beech Hill Rd. on left.
Take Beech Hill Rd. (3.5 miles) to Farnum Rd. (Charles Farnum) on right.
There is a WMBDC sign at the beginning of Farnum Road.
Club is 600 yards up on the left

From route 57

Travel 24.8 miles on Route 57W to North Lane in Granville
Take a Right onto North Lane (follow sign for Ripley Maple Corner Farm)
In 2 miles Take left onto Broden Brook Rd.
End of Broden Brook take a left onto Beech Hill Rd.
Drive approx. 1 mile and take first left Farnum Road (dirt road) after Riples
Corner Farm There is a WMBDC sign at the beginning of Farnum Road.
